*11AM Start Time.

*You must be at CCS at least 1 HOUR prior to your division start time. (Schedule with estimated times will be provided a couple days prior upon your request). You must provide photo id with your receipt / copy of registration. You must have Waiver form signed. Underage participants will need to have your birth certificate and your parent/trainer will need to verify you upon signing in.

ANY underage participants need to have parent/guardian approval with signature and contact information provided.(On Registration Form)

*The tentative schedule starts with Open divisions, No-Gi Submission Wrestling, Pankration then Kickboxing. Kid + Youth Divisions will start the day. Women then mens’ divisions follow.

PRE-Registration fee is \$56.00 ! Additional division(s) - \$11.20 . You must pre-register with payment before the FEBRUARY 25th, 2012 DEADLINE ! **Late registration costs \$67.20 with** Additional Division(s) \$16.80 and will only be accepted before 9:30AM on MARCH 3rd. If only 3 participants are registered you will be contacted by March.2nd with the option of doing a round robin, or being placed in the weight category closest to your exact weight, or you can choose to not compete and receive a full refund. PLUS Depending on the amount of participants your division could be organized with Single Elimination or Round Robin to ensure there is time for all divisions-This will be confirmed with you before event day upon your inquiry.

*You are required to provide as much detail to your registration form as possible to ensure the best possible match ups. CCSInc will be trying their best to have participants as equal as possible in experience, weight and age. CCSInc will also try to have opponents matched from an opposing team as often as possible but no guarantees depending on registration for that division. *All Weigh Ins will be held upon your arrival.
